Alt. Tagline: Efficiency at the Income Tax Department for License Payments

A critical issue that continues to plague Vincentians month after month, year after year is the harrowing queue at the Income Tax Department when driver's license payments and vehicle license payments are due.

We are all aware of the old yet famous adage 'Time is money'. There is no doubt that this is a perfect fit for this particular situation. Another suitably fitting adage 'Time, once lost can never be regained' helps me with me to bring my point home. The amount of time spent waiting in line to pay license fees is lost time that will never be regained, time that could be put to productive use thus providing monetary reward. Once this time and productivity are lost, they are lost forever. We should be well aware that all of this loss affects us all through lack of contribution that could have been made towards the economy. It is a ripple effect that affects the greater good. It affects us all whether we are aware of it or not.

With all of the above being mentioned, the idea is to provide the following:

- Driver's license owners with an online portal for paying their driver's license fees.
- Vehicle owners with an online portal for paying their vehicle licensing fees.
- Police vehicle inspectors with a portal for updating vehicles' inspection status.
- Vehicle insurance companies with a portal for updating vehicles' insurance status.

Driver's License Portal:

A driver registers for the service. Upon logging into the portal, they are presented with the option to enter their payment information and select the period of time that they wish to pay. Once this is done they approve the payment. The next step would be to collect their driver's license card from the Income Tax Department.

Vehicle License Portal:

A vehicle owner registers for the service. Upon logging in, they are presented with a list of vehicles that they own. They select the vehicles that they wish to pay for and enter their payment. Once this is done they approve the payment. The next step would be to collect the license sticker from the Income Tax Department.

Note that vehicles which do not have inspection approval or updated insurance information would not be eligible for payment. Those two criteria are covered in the following pieces.

Police Vehicle Inspector Portal:

A vehicle owner takes their vehicle to have inspection performed by a police vehicle inspector. Upon successful completion of inspection, the police vehicle inspector logs onto the Inspector Portal. They then search for the vehicle that just passed inspection and updates the inspection information for that vehicle. If the vehicle does not pass inspection then the inspector would not need to make any changes in the system.

Vehicle Insurance Portal:

A vehicle insurance company registers for the service. This may be made mandatory. Once a vehicle owner pays their vehicle insurance, the vehicle insurance company logs onto the vehicle insurance portal. They then search for the vehicle whose insurance fees were just paid and updates the information for the vehicle.

This entire system should make the whole process of driver and vehicle licensing a lot simpler. It also helps to reduce the records that police inspectors need to keep, freeing up the space that is used by the records being held now. It also reduces the paper that vehicle owners need to carry around. This is in addition to all the benefits mentioned at the beginning of this summary.
